Subject: Airtanker Base Frequency Change 2014**Area of Concern:** All Aviation Users

Discussion: The FAA reviews and engineers all aviation Air-to-Air AM frequencies for all Airtanker Bases each year. Usually, the frequency 123.975 MHz is assigned for this purpose. However, if the frequency is not available at a given location, the FAA will engineer an alternative frequency. *Due to engineering restrictions there are several new frequency assignments/changes to the National Airtanker Bases frequencies for fire season 2014.* While most bases retain 123.975 as the RAMP frequency, notable changes are highlighted in red. These changes are effective immediately.
